Job Approval: Governor Trounces Legislature, 44.6% to 19.5%


Democrats: Angelides Leads Westly, 42.6% to 38.4%

Immigration Dwarfs Other Issues In Importance: 42.6%


Voluntary Public Preschool Initiative (Proposition 82) Losing 52.4% to 36.9%

San Diego – In the poll released today by Datamar Inc., a random sample of 1,221, Californians was used. Findings are based on a telephone survey of 1,221 *California high-propensity registered voters—voters who voted in the 2000 gubernatorial primary and general elections, the 2002 recall gubernatorial election and the 2004 Presidential primary and general elections.* The poll gives Governor Schwarzenegger an *approval* rating of 44.6%, more than twice that of the legislature (19.5%).


As to *disapproval*, the governor also fares much better than the legislature. Poll respondents give the governor a disapproval/approval rating of 47.4% to 44.6%. Not so with the legislature, which receives a whopping 69.4% to 19.5% disapproval/approval rating, with over three times more respondents disapproving than approving the job performance of the legislature.




In the Democratic primary race to be the party nominee, Phil Angelides leads by a small margin, 42.6%, to Steve Westly's 38.4%, with 19% undecided. This question was available to Democrat voters only. Sample size is 542 respondents and the margin of error is +/- 4.21.




Immigration dwarfs other issues in importance at 42.6%. Public schools take a distant second at 19.9%, followed by gas prices at 11.8%, the budget deficit at 9.8%, and the economy at 9.6%.




When responses are broken along partisan lines, the difference among the two mayor political parties are very sharp. To the Republicans, immigration is the most important problem facing California today at 62.5%, with public schools being their third issue of concern at 8.3%. To the Democrats however, public schools is the number one issue at 32.5%, with immigration second at 22.1%.




Proposition 82, the Public School Initiative is losing 52.4% to 36.9% with 10.6% undecided. Males oppose it by 57.3%, females by 47.6%.







The California State Senate's passing a resolution *supporting* a May 1st boycott of jobs, schools and businesses to educate the public about contributions of immigrants did not meet with much approval. The strongly disapprove was 42.5%, the somewhat disapprove 15.1% for a combined disapproval total of 57.6%. The strongly approve was 15.6%, the somewhat approve 18.6%, for a combined approval total of 34.2%.




Looking at the results by gender of the support for the boycott resolution, the strongly disapprove was strong by gender evenly. Males disapproved 44.4% and somewhat disapproved 16.3% for a total disapproval of 60.7%. Females strongly disapproved 40.6% and somewhat disapproved 13.9% for a total disapproval rating of 54.5%.




The Democratic leaders of the California Assembly and Senate cancelled the scheduled Monday, May 1st legislative floor session. In its place they scheduled a "check-in session", which allowed legislators to receive a \$153 per day payment on top of their salaries for merely setting foot in the Capitol building, and frees legislators to attend events around the state regarding the Monday boycott of jobs, schools, and businesses. The strongly disapprove was 57% with the somewhat disapprove at 15% for a combined disapproval rate of 72%. The approval rate in strongly approve was 9.9%, and the somewhat approve was 14.5 for a combined approval rate of 24.4%.




The disapproval rating along gender lines was strongly disapprove for males 60.3%, somewhat disapprove 13.8% for a combined total 74.1%. Females also showed a strongly disapprove rating of 53.9% and a somewhat disapprove of 16.2% for a combined disapproval rating of 70.1%.




Q23. Would you be more likely or less likely to vote for a candidate for governor who supports issuing driver licenses to illegal immigrants? This question elicited a less likely rate of 65.9% and a more likely to vote of 20.8%, with 13.1% undecided.



The question of voting for a candidate who supports issuing driver licenses to illegal immigrants by gender produced a near even result, a "less likely to vote" among males by 67% and a 64.8% by females.



However, when the results are broken down by party, the Democrats consider it as "not very important by 43.1%, while the Republicans rate it "very important" at 61.3%.




Sample size 1221 +/- 2.8 percent margin of error May 9-13, 2006

Methodology: Findings are based on a May 9-13, 2006, automated telephone dialer survey of high-propensity registered voters in California using the voice of a professional announcer. A Datamar proprietary algorithm was used to generate random samples of voters for calling. The margin of error for the total sample is +/- 2.8 percent at the 95 percent confidence level. The sampling error for subgroups is larger. Question 15 was available to Democrat voters only. Sample size is 542 respondents and the margin of error is +/- 4.21. Some of the totals may not equal 100 due to rounding.

Registere d voters vs. high-propensity voters: Registered voters who *actually vote* are significantly fewer than the voters who are registered to vote. Although it is sometimes useful to determine the opinions of all registered voters (and even the opinions of the general population), surveying the opinions of *the high-propensity voters* is more efficient and predictive for electoral/political purposes.

This survey is based on defining "high-propensity" voters as those eligible registered voters who have demonstrated high-propensity by having *actually voted* in one or more recent elections, specifically:

Findings are based on a telephone survey of 1,221 California high-propensity registered voters—voters who voted in the 2000 gubernatorial primary and general elections, the 2002 recall gubernatorial election and the 2004 Presidential primary and general elections.



We believe that this past-voting-performance-based definition is superior to other predictors -- for example: *registered* Democrats far outnumber *registered* Republicans 42.7% to 34.6%. However, the *high-propensity* voters give a slight edge to Republican (45.9%) vs. Democrat (44.2%) as to turnout. The Nonpartisan and Other voters show similar voting anomalies in that their registered numbers are high but their turnout is much lower, which is why we believe that recent voting history is an accurate predictor of future voting.






Q5. What is the highest level of education you have completed?




Q6. Are you or is anyone in your household a member of a labor union, such as trade union, service employee union, public employee union, or teachers union?
















Q13. Do you approve or disapprove of the way Governor Arnold Schwarzenegger is handling his job as governor?




Q14. Do you approve or disapprove of the way the California State Legislature is handling its job?


















Q23. Would you be more likely or less likely to vote for a candidate for governor who supports issuing driver licenses to illegal immigrants?
